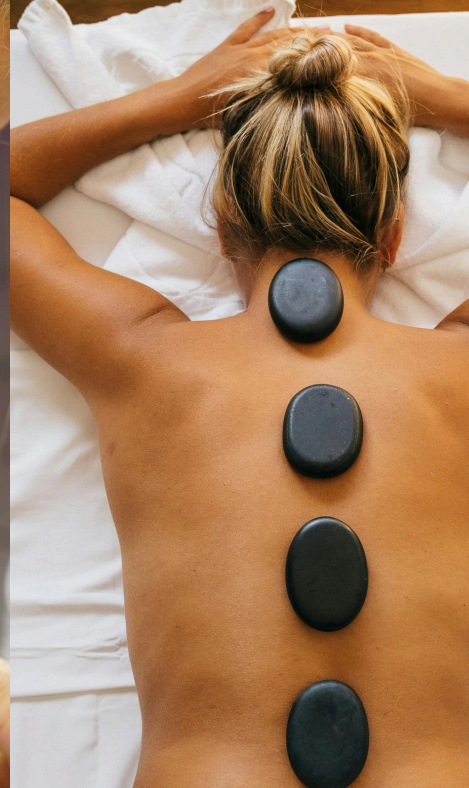

COURSE OVERVIEW

The National Occupational Certificate: Beauty Therapist NQF Level 4 carries 158 credits and is accredited by QCTO.

A beauty therapist is a specialist in beauty treatments for the face and body.

Their beauty regimen is meant to go beyond skin deep. Driven by the belief that if you look good, you feel good, their regimen serves to boost clients' overall self-confidence, relieve stress, and improve general wellbeing.

The External Integrated Summative Assessment (EISA) serves as a standardised national assessment or examination for awarding Occupational Certificates. The standardised assessment ensures consistent and credible evaluation of skills and knowledge across all occupational qualifications, part qualifications, and trades.
